## Introduction

Two Director-at-Large positions are open for election at the 2024 GymBC Annual General Meeting. These positions are elected for 2-year terms.

Sunday, October 27, 2024 at 11:59 p.m. PST was the deadline for submitting nominations for the Director-at-Large positions. In accordance with the Bylaws of the Society, nominations will not be accepted from the floor of the AGM.

The GymBC Nominations Committee is tasked with reviewing all nominations to ensure eligibility and alignment with the GymBC Bylaws, specifically, 7.3 *Qualifications of Directors* and 8.1 *Nomination of Directors*. They are also responsible for considering the skills and representation required to form an effective Board of Directors. It is in the best interest of Gymnastics BC and its members that the Board of Directors be representative of its membership – geographically and by discipline. It is also important that the Board embody a broad spectrum of relevant knowledge and skills identified as critical to effectively govern the Society. These include, but are not limited to, **leadership**, **governance**, **financial management**, **legal**, and **safe sport**.

Five nominations were received prior to the submission deadline. The GymBC Nominations Committee vetted all nominations and produced this report listing the candidates in alphabetical order in advance of the Annual General Meeting. With 15 years of experience as an Occupational Therapist, she has practiced in both acute care and private settings, specializing in pediatrics, neonates, and older adults. She is married and has three children, two of whom have participated in competitive gymnastics in both MAG and WAG.

The nominee has been the General Manager at the Langley Gymnastics Foundation (LGF) for over two years and prior to this, had served on its Board of Directors for five years, contributing to this non-profit organization. She has dedicated hundreds of hours to volunteering with LGF, Gymnastics BC, and Gymnastics Canada, assisting with the organization of competitions, events, and fundraising efforts.
