5. GBC Annual Report

- Update provided by GBC Interim Chair
- Annual report outlines the fiscal year: July 1, 2019 – June 30, 2020. However, membership numbers reflected in report are from the membership year: September 1, 2019 – August 31, 2020.
- Highlights:
 - Year of celebration – GBC 50th anniversary. Many celebrations throughout the year ending with an awards and Gala event.
 - Year of insurance issues, specifically for Trampoline usage.
 - 2020 – year of COVID pandemic.
 - Many moving and changing parts affecting our GBC community which meant quick adaptations from the GBC staff, board and member clubs to deal with these changes.
 - Staff focus on member services and risk management throughout 2019/2020.
 - Thank you to our board Chair's during this turbulent period – Ana Arciniega and Sherri Taylor.
 - Strategic planning began in spring 2019, but was put on hold while dealing with pandemic issues. Staff and the Board continued to work on Strategic Plan throughout 2020.
 - Member clubs in 2019/2020 and approximately 37,000 members.
 - Introduced Uplifter as our membership registration platform.

- Update provided by GBC Director of Finance
- Continued thanks to the GBC staff for assistance with compiling reports.
- 2019/2020 Audited Financial Statements provided to members in communications packages and GBC event page.
- Report ends June 30, 2020. Nearing the end of our fiscal year when COVID hit, so not much impact on this specific reporting period with regards to revenues etc.
- 65% of revenues from member registrations – which allows us to redistribute for insurance and programming.
- Expenses – mostly salaries and membership services. Large variance is due to bad debts, primarily due to COVID club difficulties.
- Additional details provided in Financial Report.

 - Accounts receivables that have been deemed as “uncollectable” will be categorized as bad debt.
 - Would have to be categorized as bad debt may not be able to collect that amount. This does not mean we will not pursue ways to collect.
 - When some clubs were forced to close (whether temporarily or permanently), they may not have been able to pay their outstanding debts with GBC.
 - The balances in this report were from before June 30th. Since then there has been a lot of follow up to collect these balances and GBC has managed to collect some outstanding A/R. GBC board is looking at options (ex. collections), but remains a work in progress.

6.2 Motion – Presenting the 2020 Q1 Financial Statements

- Update provided by Director of Finance
- Presenting 2020/2021 Budget
 - Document distributed to members and posted on GBC Event page for reference
 - Presenting best estimate of the budget of where we are right now.
 - Does not need to be approved by the members. Has been approved by the board and given to staff to assist with operational programming for this year.
 - Membership is way down – reduced by nearly half of regular membership reporting.
 - Government subsidies – GBC has applied for as many government support options as possible to ensure continuation of member services.
 - Most of the government funding is set to end near the end of our fiscal year.
 - Revenues: much coming from grants and less from membership registration fees. Some revenues expected with events if able to host virtual events this season.

- Expenses: most of the expenses are due to membership services, with additional expenditures for operational costs (ex. salaries, office rent), and programming expenses.
- Q1 – Financial Statements
 - Distributed to membership and also available on GBC Event page for review
 - Not audited or reviewed as they were internally generated for the AGM
 - Report spans July 1 – Sept 30, 2020.
 - Revenues: low with membership as this is not generally a registration period. Therefore, low revenues from registration fees. A lot of government funding received in first quarter.
 - Expenses: insurance (large payment in summer) and continues into fall and spring next year. Member Services expenses includes our annual fees to GymCan and insurance. Program expenses lower in the fall but may increase with events and programming in the spring.
 - Balance sheet: snapshot in time. Increase in A/R is mostly due to government subsidies that we have applied for but have not yet received the funding for. Gaming grant did come through for 2021, however cannot recognize these funds until the programs (to which the money was allocated) are run.

- Question/Comments
 - Why would the quorum be reduced?
 - At previous AGM, had difficulty meeting quorum. Meeting was delayed as GBC Staff called those that had registered to get them to attend simply to hit quorum and continue with meeting as planned.
 - Suggested by Board at that time to reduce the minimum quorum to address this issue.

Questions/comments?

- If someone becomes a member in Sept, and they close due to COVID, are they still considered a member as part of the 35% for the AGM.
 - Yes, if they are in good standing.
 - Club remains a member for the year as have paid all necessary fees to be a member for the full membership season.
 - This could affect reaching quorum for AGM. *GBC Board will need to follow up with lawyers to determine if this is correct.*
 - A member may rescind their membership if they are permanently/temporarily closed. This would require an action from the club, not from the organization.
- Individual members or a closed club in good standing, but clubs are not in good standing. Could potentially affect the quorum numbers as well.

- Is it possible to put a special resolution forward to have only active clubs can be considered for quorum?
 - Will need to verify with lawyers
 - Perhaps to create a different membership category to put these clubs into ex. affiliate or associate membership. Cannot make this amendment at this time to vote on at the AGM.
 - Each member must meet certain criteria to ensure membership, and if they have done so, they are permitted to vote at the AGM.
- Motion was determined to be voted on prior to COVID times, but given the current landscape, to reduce the number of clubs making decisions for the long-term by-laws, should not be giving less control to the members with less people participating in the AGM as voting clubs.
- Options moving forward – amendment to the motion or defeat.

 - a Person need not be a Member to be nominated as a Director for election in accordance with Bylaw 7.4(a), however if a Member is nominated, he or she must be in good standing (or be the designated representative of a Member in good standing) in order to be nominated and must remain in good standing in order to stand for election;
 - an eligible Person may nominate him or herself, and the nomination must be signed by the Person and by one (1) other Member;
 - a Member may not nominate more nominees than the number of Director positions available for election; and
