Eligibility criteria & conditions for nomination

To be eligible to be nominated, elected or appointed to serve as a director of Gymnastics BC, a nominee must:

1. Be at least 18-years of age;
2. Not be an employee of Gymnastics BC;
3. Not have been found by any court, in Canada or elsewhere, to be incapable of managing his or her own affairs;
4. Not be an undischarged bankrupt;
5. Not have been convicted of a prescribed offence within the prescribed period, for which no pardon has been granted;
6. Agree to fulfill the requirements and responsibilities of their position and abide by the Societies Act, the Society's Bylaws and all related policies; and
7. Have previous Board experience, if seeking nomination as Chair.
